Introduction

This means we are authorized to perform conformity assessments and certifications for measuring instruments before they are placed on the market or put into use.

As a Notified Body, we ensure that measuring instruments comply with EU regulations, allowing them to be legally used and sold across the **EEA (European Economic Area)**. This is essential for manufacturers and suppliers aiming to introduce their products to the European market.

Justervesenet is appointed EU notified body with id. nr. **0431** for the following measuring instruments:

- Non automatic weighing instruments (NAWI, module B, D, F, G)
- Automatic weighing instruments (MI-006 module B, D, F, G)
- Measuring systems for liquids other than water (MI-005, module B, D, F, G)
- Active electrical energy meters (MI-003, module B, D, F)
- Multidimensional measuring instruments (MI-009, module B, D, F)
